General Rules & Ordinances of Directorate of Open and Distance Learning


(Preliminary)

- 1) The University through its Directorate of Open and Distance Learning (ODL Model) programme may conduct leading to Bachelor's, Master's Degree/Diploma/PG Diploma/Certificate or any other examination under different faculties (except Professional courses eg. Engineering, Medicine, Pharmacy, Architecture and Physiotherapy, as specified by UGC), subject to the conditions; as may be specified by the University from time to time.
- 2) The courses of study, duration of courses, the medium of instructions and examination, mode of examination, shall be as specified in the syllabi of Open & Distance Learning (ODL) Mode. Examination pattern will be credit based system (CBS) under semester mode.
- 3) Eligibility criteria for admission and evaluation, unless otherwise specified, shall be the same as for regular courses.
- 4) The University shall establish Directorate of Open and Distance Learning (hereinafter to be called the 'Directorate') and, besides the Director, may appoint the requisite staff for the smooth and efficient functioning of the Directorate.
- 5) The functioning of the Director may include:-
 - i) admit students in different courses directly or through some Learner Support Centre(s), which may be approved for the purpose as per the procedure that may be specified by the University from time to time.
 - ii) shall attend to the administrative and academic duties of the Directorate.
 - iii) shall be the overall supervisor and shall also monitor the conduct of the courses that will be offered by the University from time to time.
- 6) The fee & funds etc. for each course under ODL mode shall be as specified by the University from time to time.
- 7) The University shall notify the dates of admission, dates for submission of application forms as well as dates of such examinations to various courses.
- 8) The University will notify the result of the various examinations.
- 9) The Vice-Chancellor may appoint preferably the Head/Next Head of the Guru Nanak Dev University Regional Campuses, its Colleges and its Constituent Colleges, as the Coordinator/Deputy Coordinator, who will coordinate the programme in the concerned subject.
- 10) It shall be mandatory for Directorate:-
 - i) to mention the name and place of 'Learner Support Centre' on all the certificates or mark sheet issued to the learner.

- ii) to mention in the mark sheets and degree about the mode of delivery i.e. Open and Distance Learning, and the photograph and the Unique Identification or Aadhaar Number of the learner in all the documents issued.
- iii) to mention 'Date of Admission' and 'Date of Completion' on each of the certificates (in semester or end of the semester or end of the programme or course) issued.

11) In any case, rules under this programme are not available/silent, relevant provisions contained in the University calendars' as well as 'The Gazette of India: Extraordinary' Part III Section 4 No. 247] dated 23rd June, 2017 - University Grants Commission (Open and Distance Learning) Regulations, 2017 and amendments published from time to time will be applicable.



Learner Support Centre(s)

- 1) The Guru Nanak Dev University may establish 'Learner Support Centre(s) in its Regional Campuses, Colleges, Constituent Colleges and Affiliated Colleges.
- 2) The University will charge fee and other charges as may be fixed by it from time to time from these Learner Support Centre(s).
- 3) In case a Learner Support Centre is Guru Nanak Dev University College, its Constituent College, Regional Campus or Affiliated College, the Principal/Head/Associate Dean or his/her nominee will be the Coordinator of the concerned Learner Support Centre.
- 4) The Learner Support Centre(s) shall charge fee and other charges (inclusive of University Fee etc.) from students admitted under this programme as may be fixed by the University from time to time. The Centre shall be solely responsible for the collection and timely remission of these fees and charges as per the rules and regulations to the University.
- 5) The Learner Support Centre shall function under the overall supervision and monitoring by the Director, Directorate of Open and Distance Learning, Guru Nanak Dev University, Amritsar.
- 6) The Learner Support Centre will:
 - a) admit students under the Open and Distance Learning programme, subject to the fulfillment of their eligibility conditions. In case a student fails to fulfill the eligibility conditions, his/her admission will be cancelled.
 - b) submit class-wise return of the students along with the requisite documents to The Director, Directorate of Open and Distance Learning, Guru Nanak Dev University, Amritsar, within 15 days after all admission dates are over.
 - c) appoint or arrange (in the proportion to be instructed by the University), Qualified-University approved-staff to impart educational instructions to these students.
 - d) collect and send the filled up, complete in all respects, the examination forms to the University as may be directed from time to time
 - e) record Aadhaar details or other government identifiers of learners.
 - f) maintain the record of the entire process of selection of candidates, and preserve such records for a minimum period of five years.
 - g) exhibit such record on its web-site and be liable to produce such record, whenever called upon to do so by any statutory authority of the government under any law for the time being in force.



Ordinances of Courses under Open and Distance Learning

The University shall impart instructions in courses as may be specified by the university from time to time by mode of Semester System under Credit Based Evaluation.

1. Eligibility for Admission and duration of the courses

The Eligibility and duration of the courses shall be as prescribed by the University from time to time.

2. Fee

Every candidate shall pay such fee to the Institution under the jurisdiction of the University as prescribed from time to time.

3. Scheme of Instructions-Examination

For each examination, every student admitted to the courses under the semester system must be on the rolls of the Institution, and shall send his/her admission form and fees for the examination through the Principal/Head/Associate Dean of the Institution, accompanied by the certificate of having good moral character.

a) The syllabi, courses of reading and regulations for the courses shall be notified by the University from time to time, and shall be deemed to constitute integral part of the ordinances. Course evaluation under the semester system of evaluation shall be done on marks/grade basis. If a course has both the theory and practical components, the student will be required to pass both the components, separately. However, if the student fails in theory, but is passed in practical of that course, he/she will be required to clear the theory paper only, and vice-versa.

b) Carry on system for various semester examinations will be as per rules applicable for Colleges.

Grading System

The Grading will follow Credit-Based System, the details of which are given below: While undertaking the course work, the following terms are defined:

- 'Course' means a semester.
- 'Credit' means weightage assigned to a course
- 'Grade' means a letter grade assigned to a student on a 10 point scale.
- 'Grade' point means points assigned to a letter grade.
- 'Semester Grade Point Average' (SGPA) means weighted average of grades in a semester.

Where G_i are the grade points in the i^{th} course and C_i are the credits registered for the i^{th} course, for all the 'm' number of courses in a particular semester.

$\sum (G_i \times C_i)$ = Total grade points obtained by a student in a semester,


$\sum C_i$ = Total credits registered by the student in that semester.

'Cumulative Grade Point Average' (SGPA) means weighted average of grades in all the semesters, at the end of any semester or at the end of the course completion.

Where G_i are the grade points in the i^{th} course and C_i are the credits registered for the i^{th} course, for all the 'n' number of courses in all the semesters. SGPA and CGPA shall be calculated up to two decimal places, after rounding off the third decimal to the nearest second place integer decimal, hence 0.005 to be increased to 0.01.

The student would be awarded a letter grade on a 10 point scale on the basis of his/her performance. Grades and equivalence between selected percentages in absolute marks system and CGPA is as follows:

Conversion from CGPA to Percentage:

A CGPA of 6 will be considered equivalent to 60% marks. The conversion of CGPA to Percent Score will be carried out by multiplication of respective CGPA by a factor of 10.

- A student shall be required to maintain a minimum of **4 CGPA** at the end of the even semester of each academic session. If his/her CGPA falls below **4** at the end of second semester of any year, the student will be declared as having failed in that year and will have to seek readmission to the first semester of that year.
- CGPA will be calculated from sum of internal assessment and marks obtained in end term examination.
- A student getting 'F' Grade in any subject will be treated as having failed in that subject. If he/she fails in a subject, he/she will have to repeat the subject and will have to obtain at least 'P' grade in that subject, within the maximum period defined (UGC Letter no. F.12-I/2015 (CPP-II) dated 15.10.2015) to complete the degree/diploma for that subject.
- It will be compulsory for a student to appear in the End-Semester Examination (Major Test). A student who does not appear in the End-Semester Examination (Major Test) will be treated as having failed in that course and will be awarded 'F' Grade.
- Re-evaluation shall be allowed as per ordinances.
- The medium of instructions shall be as already existing in the ordinances.
- Grace marks will be allowed as per University ordinances.

A CGPA of 6 will be considered equivalent to 60% marks. The conversion of CGPA to Percent Score will be carried out by multiplication of respective CGPA by a factor of 10.

- A student shall be required to maintain a minimum of **4 CGPA** at the end of the even semester of each academic session. If his/her CGPA falls below **4** at the end of second semester of any year, the student will be declared as having failed in that year and will have to seek readmission to the first semester of that year.
- CGPA will be calculated from sum of internal assessment and marks obtained in end term examination.
- A student getting 'F' Grade in any subject will be treated as having failed in that subject. If he/she fails in a subject, he/she will have to repeat the subject and will have to obtain at least 'P' grade in that subject, within the maximum period defined (UGC Letter no. - It will be compulsory for a student to appear in the End-Semester Examination (Major Test). A student who does not appear in the End-Semester Examination (Major Test) will be treated as having failed in that course and will be awarded 'F' Grade.
- Re-evaluation shall be allowed as per ordinances.
- The medium of instructions shall be as already existing in the ordinances.
- Grace marks will be allowed as per University ordinances.
- Maximum time allowed to pass a course is given below:

i) Re-examination/Supplementary examination of end semester examination shall be conducted as per following schedule:

It is further clarified that the candidates appearing for odd semester of end-term/supplementary examinations shall appear during odd semester examinations to be conducted during Nov/Dec only (as per sr. no. 1 in above table) and candidates appearing for even semester of end-term/supplementary examinations shall appear during even semester examinations to be conducted during May/June only (as per sr. no. 2 in above table). Odd semester papers' shall be conducted along with the next odd semester end term examination and even semester along with the next even semester end term examination.

A candidate, who has secured less than 35% marks in internal assessments, may be allowed to re-appear in concerned subject along with end-term examination, as per schedule mentioned above.

j) The candidate shall be treated to be failing in the courses offered in the semester in which he has not sought admission/dropped the semester and such courses/papers in which the candidate has failed shall be taken into account while deciding the promotion of the candidate in subsequent semesters as per the condition. The candidate shall be required to seek admission into the second semester examination as a regular candidate at the end of the prescribed duration of the course, but within the maximum time allowed to pass a course as given under para (h) of the ordinances, provided that he fulfills all other requirements under the prevailing ordinances. Regular students admitted to a course shall register/enroll themselves with the university in the very first semester of their admission and pay prescribed fee to the college/University. Direct admission to second semester is not allowed. The same rule shall apply to Open & Distance Learning (ODL) Mode, private and capacity enhancement programme students.

The above shall also apply to all such courses in which admission to a college is a prerequisite as a regular student. The above provision is extended to all the Under Graduate, Post Graduate Courses & Diplomas. This provision shall also be extended for subsequent semesters.

Signature

4. Assignments

The candidate shall be required to submit assignments as mentioned in the course by the month of **November / April** of subsequent semester of the course, in which, he/she is registered. Submission of assignments within due dates is prerequisite for appearing in the term-end examination.

5. Discipline

Each student shall be under the control and discipline of the concerned institution/Learner Support Centre. In case of any misconduct on the part of a student, the institution/Learner Support Centre shall have a power to take disciplinary action against the defaulter, to the extent of cancellation of admission of the defaulting student from the rolls of the institution.

6. Evaluation and Certification

- The examination of the programmes in Open and Distance mode shall be managed by the examination and evaluation unit of University and shall be conducted in the examination centre approved by the University.
- The successful candidate shall be awarded the degree in the subject of his/her study indicating the CGPA obtained on the basis of the result of all the semester examinations. A student who does not complete the programme of study within the minimum duration of the course of his/her study, or fails in any course, shall not be eligible for any merit position/medal/award of the University.
- Diploma/Degrees pertaining to all the courses offered under Open and Distance Learning (ODL) Mode will be treated at par with the regular courses.
- In case, rules under this programme are silent, relevant provisions contained in the 'The Gazette of India: Extraordinary' Part III Section 4 No. 247] dated 23rd June, 2017 – University Grants Commission (Open and Distance Learning) Regulations, 2017 and amendments published from time to time and University's Common Ordinances under credit based continuous evaluation grading system, Acts, Statutes, & Regulations etc. will be applicable.

Subject: Proceedings of the meeting of the Committee constituted to amend the promotion policy for ODL courses under Directorate of Open & Distance Learning, GNDU, Amritsar

A meeting of the Committee constituted by the worthy Vice-Chancellor to amend the promotion policy for ODL courses offered by the University under Directorate of Open & Distance Learning was held on 27/01/2022 in the office of Dean, Academic Affairs. The following members were present:

1. Dean Academic Affairs
2. Registrar
3. Dean, CDC
4. Professor Incharge (Exams)
5. Director, ODL
6. System Administrator (Exams)
7. A.R. (Regulations)

After thorough deliberations, the following recommendations are made:

The committee members thoroughly studied the ODL ordinances and common ordinances for Credit Based Evaluation and Grading System. It was observed that promotion policy for maintaining 4 CGPA at the end of even semester of each academic session for ODL students earlier was similar to as per ordinances of the Credit Based Evaluation and Grading System. However, the promotion policy under Credit Based Evaluation and Grading System has been modified vide Para no. 6.7 of the Syndicate meeting held on 29.08.2019 at page no. 7 (copy attached as Annexure-I). The committee members recommended to adopt the same promotion policy of maintaining the 4 CGPA at the end of the final semester in place of minimum 4 CGPA at the end of even semester of each academic session for ODL students similar to decision of the Syndicate in Credit Based Evaluation and Grading System (Page no. 7 & 8) in its meeting held on 29.8.2019 as proposed below. This amendment will be applicable from current session 2021-22.

Promotion Policy for maintaining 4 CGPA at the end of even semester of each academic session for ODL students earlier was similar to the credit based continuous evaluation system, however the promotion policy under credit based evaluation and grading system has been modified by para no. 6.7 dt. 29.08.2019 at page no. 7 & 8 (copy attached as Annexure-II) to make it more clear in common ordinances run for credit based and evaluation system w.e.f. 2018-19.

A meeting of the Committee constituted by the worthy Vice-Chancellor to amend the promotion policy for ODL courses offered by the University under Directorate of Open & Distance Learning was held on 27/01/2022 in the office of Dean, Academic Affairs. The following members were present:

After thorough deliberations, the following recommendations are made:

The committee members thoroughly studied the ODL ordinances and common ordinances for Credit Based Evaluation and Grading System. It was observed that promotion policy for maintaining 4 CGPA at the end of even semester of each academic session for ODL students earlier was similar to as per ordinances of the Credit Based Evaluation and Grading System. However, the promotion policy under Credit Based Evaluation and Grading System has been modified vide Para no. 6.7 of the Syndicate meeting held on 29.08.2019 at page no. 7 (copy attached as Annexure-I). The committee **members recommended to adopt the same promotion policy of maintaining the 4 CGPA at the end of the final semester in place of minimum 4 CGPA at the end of even semester of each academic session for ODL students similar to decision of the Syndicate in Credit Based Evaluation and Grading System (Page no. 7 & 8) in its meeting held on 29.8.2019 as proposed below.** This amendment will be applicable from current session 2021-22.
